Commodore's Comments.

At last, it seems we can make plans for the next season. Few of us thought we would be still in the grip of the pandemic so far into 2021 but the signs are that by May we should be getting back to something like normal.

For the club, a promising level of bookings for both boats gives me some optimism that we shall be in full swing by the summer though I suspect that it will take a few years for club finances to be restored to their 2019 levels.

Brexit has added some complications to the sailing world. Danny is updating the Explorer Skipper Instructions to include what skippers need to do before setting off to the EU. For Ploes our concern is to maintain our EU VAT Tax Paid status. Whilst this is not strictly a Brexit issue, the lack of clarity in some countries caused by Brexit means that we will have to be extremely careful on our next visit into EU waters.

We have lost a few members this year, as we do every year for various reasons, however the challenge for the club is to replace them and word of mouth is by far the most effective means of recruitment, so please spread the word. If you need more publicity materials, cards leaflets or posters please let me know.

Our new generation of sailors are rejuvenating the club and its fantastic to see so much energy and enthusiasm - particularly on the WhatsApp group.

You would be forgiven for thinking that not a lot has been happening since lockdown version 3 commenced after Christmas. In fact you would be wrong as members have been working behind the scenes on various projects.

Colin dashed to the boat the day before lockdown to examine the wiring and has been continuing to work on the circuit diagram at home. Paul N has been inspecting the boat on a weekly basis as he lives nearby and can work a visit into his exercise routine. Luckily, he reports no problems. The low wattage heater we bought last autumn, combined with condensation absorbing tablets, have kept the interior nice and dry. There's very little water getting into the bilge and Cliff's water tank repair has been successful.

Paul retrieved the east coast charts from the boat and posted them to Chris Jones who kindly volunteered to mark up the updates. This task has now been completed and we will purchase a new set of charts when Imray re-publish them.

Danny Heartshorne has been busy reviewing the documents on board both boats (radio licenses, EPIRB registration) and updating as necessary. He has also volunteered to update the Explorer Skipper Instructions.

For my part, I had arranged to meet Chris Jeckells, the sail maker, at the boat on 6th January to measure up for the new genoa. Needless to say, that didn't happen. Hopefully we can rearrange for soon after 29th March.

Talking about dates, the rule of six meeting outdoors and being allowed to travel outside your local area comes into effect 29th March. This means we can get back to the boat for maintenance and for day sails. I'm delighted to report that Rob Holland (new skipper last year) has booked the boat for five consecutive day sails from 5th April. He will be looking for skippers to join him, on days that suit, free of charge, to help him become more familiar with the boat and local area. He's on the WhatsApp group if you can help.

From 12th April staying in self-contained holiday accommodation is allowed. Hopefully this also applies to boats so long as you don't sneak ashore to use the shared ablution blocks! This has the potential to be a bumper year for Explorer so get your bookings in! Happy sailing

Ploes

We are very hopeful of an excellent year on Ploes this year, we already have 11 weeks booked but unfortunately due to the Covid lockdown we do not know exactly when Ploes will be available to be able to be commissioned? Turkey is not open at the moment for flights, locals hope for information by early March, and the UK Government do not want us to travel overseas before the middle of May. The UK Govt announced on the 22nd February that it looks like international travel could commence on the 17th May, but this could be delayed.

We are continuously monitoring the situation and adapting our plans to suit. We will reassess this situation in April at our Sailing Committee meeting and decide then what we can do. At the moment Paul Newman and I were booked to go out to Turkey to commission Ploes in mid April, but our trip has been delayed until the middle of May at the earliest. We then plan to do checks and to assess what we need to do to get Ploes in top notch condition. The first booking on Ploes is the week starting on the 22nd May.

Our plan at the present for this year is to carry on minimising expenditure until we know the likely use this year of Ploes. Claire checks Ploes every week, she reports Ploes is safe and warm without any galvanic current Led indicator issues. Claire has tested the saildrive on Ploes under load several times (with Ploes restrained to the pontoon) and the excellent news is that the oil is still clear and the drive is watertight. Claire has also recently painted the bow thruster compartment and Levent has cured a water leak from the Anchor chain locker.

Our worries for the future is that we have the bow thruster missing, long term we need to fit a new bow thruster and we will reassess this at our April Committee meeting. Fitting a new bow thruster will be about £2000 plus labour and it will cost another £2000 as Ploes will need to be lifted from the water. We will also do the annual antifoul on Ploes at that time, but this work will be delayed until we know the likely use of Ploes this year.

The issues ahead are that if we require work to be done on Ploes after our visit in May, then Levent's yard will be very busy and we will have to wait for the yard to be available for our work. We may even have to wait for the summer and we then could lose our early summer bookings, but it is difficult at this stage to predict what we will be able to do and when we can do it. At the moment we are researching and waiting for the travel restrictions to be lifted in both the UK and in Turkey, we can then take the first steps.

I am confident that we will have a busy Autumn sailing season, I am very optimistic that with our vaccinations, we are seeing the back of all these Covid delays and we will have a good season on Ploes.

In light of the on-going restrictions, and with Explorer currently being based at SYH, we took the decision this year to not renew our affiliation with the RNSYC. However, Simon Cadle, Club Manager has kindly agreed that our members are more than welcome to use the Club under visitor's rules in the meantime.

Explorer Summery Cruise 2021 – Boldly going into the post COVID world.

Before writing this I took a look back at previous cruise 'kick off' articles I have written. Last year, just a few months before we locked down, I laid out an ambitious plan for a six week trip down the UK coast to the Solent, across to the Channel Islands, and returning along the French coast. I was aware of plenty of risks but a global pandemic was not among them! However we did manage a much shorter cruise along our coast as far as Poole.

So to summer 2021.....

As of today, 3rd March, the situation is looking promising. Our government has a clear plan to exit lockdown and by the end of spring most adults will have had at least their first vaccination. Officially the first date for more than two families being allowed to mix is 21st June. A summer cruise is definitely possible but we need to plan to be handing over in UK mainland ports, this is what we have generally done anyway as it is easiest for logistics. We also need to have a plan which is flexible to changes in dates when mixing in permitted.

We have an offer to deliver the boat to the Solent and working from that I propose that we initially look to schedule four additional weeks of cruising ending up back in SYH. Four weeks is conservative but if there is additional demand we can easily add more weeks and maybe extend the range. The cruise will be capped at a maximum of eight weeks away from SYH.

Step 2 – I take the information from step 1 and lay it out in a timing plan. (Ready by 11^{th} April)

Step 3 – We circle around a few iterations of different dates, locations, and late replies, to arrive at a plan that works for everyone. (Ready by 21st May). In reality this often goes on longer....

My aim is that everyone who wants to participate can. This is not always possible but it is my aim.

Media

Social Media Accounts -

I have updated the website with our latest prices, so we are ready for 2021 season, the website booking system for this year is also working and has been tested. Understandably all media accounts are quiet during the winter season, but we have had quite a lot of activity in our WhatsApp subgroups. Once the restrictions are lifted and the season begins then our media accounts are ready to start promoting our sailing year.



Covid Guidelines

The following are taken from the RYA Guidance. They should give members a steer on when and how to manage their bookings. However if more detail is required please access the RYA website and look for:

'RYA Guidance on Sailing and Racing with Participants from Different Households during Covid-19 in England

The club relies on the skippers making bookings to do so in accordance with these guidelines.

At the moment there is no foreign travel allowed (except for certain reasons) until 17th May.

Step 1: 29 March

Outdoor sports facilities including sailing clubs can reopen, subject to the Rule of six/two households. The Rule of six means that (apart from a set of limited exemptions including work and education) any social gatherings of more than six people are against the law. Formally organised outdoor sports – for adults and under 18s – will also restart and where compliant with guidance issued by the national governing bodies (the RYA) will not be subject to the gatherings limits. Indoor facilities, such as changing rooms, should not be used at this time, although toilet facilities can be accessed.

Will it be possible for people from different households to sail together in the same dinghy, keelboat or yacht and is there a limit on the numbers onboard?

Yes. Organised activities should comply with the RYA Guidance on Mixed Household Sailing and Racing. Organised activity is any activity organised/delivered by an RYA affiliated organisation, which may include racing or recreational activity. Activity that falls outside of this should conform with the wider social contact regulations, which include social distancing and the Rule of six/two households.

Step 2: no earlier than the 12 April

Overnight stays away from home in this country will be permitted and self-contained accommodation - those that do not require shared use of bathing, entry/exit, catering or sleeping facilities - can also reopen, though must only be used by members of the same household.

Hospitality will be able to open for outdoor service, with no requirement for a substantial meal to be served alongside alcoholic drinks, and no curfew. The requirement to order, eat and drink while seated ('table service') will remain.

Step 3: no earlier than the 17 May (as per above and in addition)

Indoor hospitality will be permitted with no requirement for a substantial meal to be served alongside alcoholic drinks, and no curfew. The requirement to order, eat and drink while seated ('table service') will remain.

Overnight stays away from home in this country will be permitted subject to the Rule of six/two households.

The Government will further ease limits on social contact, enabling people to make informed personal decisions.

Step 4: no earlier than the 21 June (as per above and in addition)

The Government hopes to be able to remove all legal limits on social contact.
